PROGRAM SUMMARY

At Reinvestment Fund, we work together with businesses, local governments, and community leaders, to ensure that every child—no matter what neighborhood they live in or where their family works—has the opportunity to get the best possible start in life through a high-quality early childhood education. We support local child care sectors by delivering technical assistance, and increasing their access to capital via grants and loans. Our current Early Childhood focus areas are:

- High quality ECE facility expansion
- ECE facility improvements
- Child and Adult Care Food Program (CACFP) coaching and expansion
- Sustainable business practices

WHERE WE WORK

We currently administer ECE programs in Atlanta, GA; Philadelphia, PA; and Washington, DC.



DESCRIPTION OF PROGRAM ACTIVITIES

<u>Project predevelopment:</u> ECE providers may have access to grant funding to properly plan for their ECE facility projects. Predevelopment consultants may be useful with understanding child care licensing and other local licensing required for the project to be successful. Additionally, ECE providers may need access to architectural, environmental analyses, and other professional services, such as legal, during their predevelopment phase.

<u>Capital Project Management:</u> Construction monitoring is a key function of our facility projects. Construction project monitoring allows Reinvestment Fund to understand the plans and cost for proposed facility projects, requirements, project progress, payment schedules and project completion. Additionally, through construction project monitoring, RF can mitigate risks associated with construction projects and address project-related issues as they may arise.

<u>Trainings, webinars, Technical Assistance and Consultation:</u> Reinvestment Fund supports local child care business owners and directors with peer learning opportunities and access to quality training and workshops on topics of interest. These topics include child care business management, fiscal management, licensing and certification, parent engagement and communication, leadership cultivation, facilities resources, CACFP sponsorship, and more. Additionally, as part of our proven grantmaking and capacity-building model, many of our ECE grant programs are coupled with individual technical assistance and consultation for grantees. Individual TA needs may vary but will generally focus on business planning.

To support the goals of the ECE Team, Reinvestment Fund is seeking expert professional service providers to enter our consultant pool to provide the program activities listed above.
