Philadelphia's Childcare Map


Quantifying Access to Care Across Philadelphia

What We Measure

Supply. Tracking the location and capacity of programs in the birth-to-five market

Demand. Estimating demand in each census block group from families and commuters

Shortage. Measuring gaps to inform public and private investments in quality improvement



How It's Used

Replicated in cities across PA, GA, NJ, DC, MD, and RI

Informs investment strategies in Phila., Atlanta, and DC

Used by stakeholders across organizations, agencies, and sectors



Per Capita Investments in ECE by Sources, 2016 to 2020








#3: How Parents Look for Care is Changing

Share of Days Parents Worked From Home, October 2023






Implications for the Sector:

Number of Licensed Home-Based Providers in Philadelphia




Factors Influencing Loss of Home-Based Programs

- Owner Retirements and Succession Planning




#5: Access to Care Benefits Communities Beyond Just Children and their Parents




Students That Lived in Elementary Catchments with Enough High-Quality Seats for >30% of Children Outperformed Peers in Catchments without High-Quality Seats



Where do we go from here?

Build on Success and What We Have

- Complement shortage measures with information on families and caregivers
- Continue collaboration between funders, lenders, technical assistance providers
- Support spaces that connect providers, caregivers, and other stakeholders

Address System-Level Challenges

- Address long-running need for adequate funding and resources in the sector
- Improve policies and systems so they work for early learning businesses
- Invest in neighborhood assets and infrastructure that support children and families
